

## CAOHC- Approved Occupational Hearing Conservationist Recertification Course

Online: February 17, 2025

Onsite: Davenport, IA Feb 18 or Altoona, IA Feb 19

**STATEMENT OF PURPOSE:** This course is designed to provide a review of the basic components of hearing conservation in industrial settings and prepare participants to continue performing hearing testing and otherwise support their hearing conservation programs.

This hybrid course provides online instruction via Zoom, and a face-to-face half-day of hands-on, practical training, after which students will take the standardized CAOHC recertification exam online.

### **OBJECTIVES:**

Upon course completion, participants will be able to:

1. Describe the responsibilities and scope of practice of Occupational Hearing Conservationists.
2. Identify parts of audiometric equipment, maintenance, calibration requirements, and potential issues with equipment or testing environment.
3. Administer pure tone air conduction audiometric tests, compliant with federal standards.
4. Manage special issues in hearing conservation.
5. Identify types and causes of hearing loss, and bases for appropriate review and referral.
6. Discuss federal and state regulations regarding hearing conservation.
7. Identify hearing protection device types, and describe purposes, fitting, maintenance, and efficacy.
8. Discuss requirements for hearing conservation education, and ways of improving motivation.
9. Identify necessary record-keeping for compliance with regulations and for best practice.

### About the Exam:

The CAOHC online certification exam will be administered at the end of the class. **Students will be responsible for providing their own laptop/tablet to access the exam.** The examination is a standardized test produced and graded by CAOHC, consistent with ANSI and ISO standards. Results are given once the exam is submitted. In the event that a student does not pass the initial exam, there is a remotely proctored online retest. The class registration includes the \$100 CAOHC certification and exam fee.

**Additional resources:**

CAOHC offers both a Hearing Conservation Manual and a Study Guide for students. While class notes and presentations are designed to comprehensively cover hearing conservation in preparation for the exam, students may benefit from supplementing their course experience with one or both of these resources. Ordered materials will be sent out with course notes in advance of the class.

**Cancellations:**

In the event that an attendee has tested positive for COVID-19 or other infectious illness, or is experiencing symptoms, an alternate date for completion of the face-to-face portion will be scheduled, or a full refund will be provided.
